examines the political consequences of natural resource abundance and the limits of resource-based growth policies in Latin America and Africa. Dr. Gregory Bix, professor of neurosurgery and neurology, is the director of the Clinical Neuroscience Research Center; vice chair of clinical and translational research, Department of Neurosurgery; and the Vada Odom Reynolds Chair in Stroke Research. He also holds the position of clinical lecturer (honorary) at the University of Glasgow, adjunct professor at the Queensland University of Technology, and professor (honorary) at the University of Manchester. He completed his clinical and research training at Baylor College of Medicine, the University of Pennsylvania, and Thomas Jefferson University. Prior to coming to Tulane, he served as the director of the Center for Advanced Translational Stroke Science and was the Paul G. Blazer Professor of Stroke Research at the University of Kentucky. He has published more than 50 papers in reputed journals, won several research awards, and holds more than 20 worldwide patents for his various scientific discoveries. Bix is the principal investigator on several NIH grants, serves as a regular member for

multiple NIH study sections, and sits on the editorial board of more than a dozen scientific journals. Bix's research focus is on the role and therapeutic potential of the extracellular matrix and its receptors in stroke, vascular dementia and traumatic brain injury.

RONALD BLANTON, MD

Professor and Chair, Department of Tropical Medicine School of Public Health and Tropical Medicine

Dr. Ronald Blanton earned his MD from Case Western Reserve University and went on to obtain an MS in genetic epidemiology there too. His subspecialty is infectious diseases. He comes to Tulane from the Center for Global Health and Diseases, where he worked on basic molecular biology of schistosome parasites, drug responses to echinococcal infections and human genetics of dengue hemorrhagic fever. His field sites have included Kenya and Egypt, but primarily Brazil. The main topics of his current research are the application of population genetics to public health and community antimicrobial resistance.

Bundy's research seeks to identify men and women at high risk for cardiovascular disease by focusing on subclinical disease, hypertension and novel risk factors or therapeutic targets. Bundy is interested in testing interventions in clinical trials and employing innovative statistical approaches for evidence-based medicine, including novel risk prediction methods, and exploring the intersection of technology and disease prevention. *Expertise: Cardiovascular disease epidemiology, hypertension epidemiology, chronic kidney disease epidemiology, meta-analysis*

RUTH CARLITZ, PhD

Assistant Professor, Department of Political Science School of Liberal Arts

Ruth Carlitz earned her PhD in political science from the University of California–Los Angeles in 2016. From September 2016–June 2019, she was a postdoctoral research fellow with the Program on Governance and Local Development at the University of Gothenburg in Sweden. Her research looks at government responsiveness from the "top down" (how governments distribute public goods) and the "bottom up" (what citizens and non-governmental organizations can do to promote transparency and accountability). She focuses primarily on East Africa, inspired by her experience living and working in Tanzania for two and a half years prior to graduate school.

REBECCA CARR, MFA

Rebecca Carr has been an adjunct faculty at Tulane SoPA since 2007. She is honored to join as a professor of practice in digital design in 2019. Carr received her MFA in graphic design from the Savannah College of Art and Design in 2005. AMANDINE M. CATALA, PhD

ANTOINE CHAANINE, MD

Assistant Professor, Department of Medicine-Cardiology School of Medicine

Dr. Antoine Chaanine's research has focused on understanding the role of mitochondrial autophagy and perturbations in mitochondrial morphology, dynamics and function in heart failure. His most recent work focuses on the role of the FOXO3a-BNIP3 axis in altering endoplasmic reticulum-mitochondrial calcium homeostasis and its consequences on mitochondrial dynamics and function as well as calcium cycling in heart failure. The FOXO3a-BNIP3 pathway is activated in animal models of pressure overload induced heart failure and in human systolic heart failure and contributes to mitochondrial dysfunction, myocardial remodeling and systolic dysfunction. He is trying to develop strategies inhibiting this pathway as a potential therapeutic strategy for patients with a remodeled left ventricle and decreased systolic function.

SUZANNE CHANG, PhD Assistant Professor, Finance A. B. Freeman School of Business

Suzanne Chang joins Freeman from the Leonard N. Stern School of Business at New York University, where she earned her master's and PhD in finance. Her research interests are in behavioral, household and corporate finance. Her dissertation focuses on how local industry conditions influence the investment decisions of mutual fund managers. Prior to her doctoral studies, she worked in the Capital Markets Section at the Federal Reserve Board. She also holds a bachelor's degree in economics from Northwestern University.

HONGWEI CHEN, PhD

Hongwei Thorn Chen is a scholar of Chinese and east Asian film and media cultures. Chen's research interest is how institutions attempt to govern with technological media, and how media, in turn, trigger crises of governmental reason. He is working on a book that examines how "education" and "tutelage" served as organizing rationalities of institutional film used in China during the early-20th century. The book unfolds Chen's broader interests in colonial modernities and their legacies in east Asia, modern China, and transnational histories of film and visual culture.

Trey Cummings joined the faculty at the A.B. Freeman School of Business at Tulane after receiving his PhD in strategy from the Olin Business School at Washington University in St. Louis. His research focuses on innovation with an interest in understanding how firm attributes such as structure, positioning and knowledge affect innovation outcomes by altering the motivation or ability of knowledge workers to innovate. In addition, his work investigates the effect of these firm attributes on the top management team's strategic direction of innovation. His work has been published in the *Strategic Management Journal*. Prior to his career in academia, Cummings worked in financial analyst and management roles at The Boeing Company on both the defense and commercial sides of the aerospace industry.

MARIE DAHLEH, PhD

Senior Professor of Practice, Department of Mathematics; Associate Dean for Strategic Initiatives and Program Development School of Science and Engineering

Marie Dahleh received her BA in mathematics from Mount Holyoke College in 1985 and her PhD in applied and computational mathematics from Princeton University in 1990. Her interest in computational fluid mechanics brought her to the National Center for Atmospheric Research as a postdoctoral fellow and to UCLA as an NSF postdoctoral fellow in mathematical sciences. At the University of California-Santa Barbara, her positions included visiting assistant professor in mechanical engineering and acting associate dean for undergraduate studies. In 1995, UCSB students selected her as one of 10 terrific teachers on campus. During this time, she co-authored the fifth edition of The Theory of Vibration with Applications with William Thomson. She left UCSB to be the first assistant dean for academic programs for the School of Engineering and Applied Sciences at Harvard University. Prior to coming to Tulane, Dahleh created the Engineering Science program for Aurora University in Aurora, Illinois, where she served as the first department chair for mathematics, computer science and engineering. Dahleh's enthusiasm for introducing students

to STEM motivated her to create several courses at Aurora with the intention of making engineering concepts accessible to a broad range of students including MBA students, undergraduates needing general education credit, and high school students on the autism spectrum.

MARK DAL CORSO, MD

Clinical Associate Professor, Department of Global Community Health and Behavioral Sciences School of Public Health and Tropical Medicine

Dr. Mark Dal Corso is a physician who is board certified in pediatrics and trained in preventive medicine. He currently provides pediatric services to Spanish-speaking populations, while training LSUHSC pediatric residents through Daughters of Charity Health Services in New Orleans, which is a federally qualified health center. At Tulane, he teaches three graduate-level courses in the Department of Global Community Health and Behavioral Sciences and two courses in the undergraduate public health degree program, and is the faculty adviser for the MD/MPH rotation in the School of Medicine. Prior to joining Tulane, Dal Corso worked as the medical director of the Louisiana HIV/AIDS Services Program at the Louisiana Office of Public Health and with GoToNations, a Christian nonprofit providing medical care and community health training in Central America. He received his MD from the Universidad de Monterrey in Monterrey, Mexico, and his MPH at Tulane University School of Public Health. His residency training in pediatrics and preventive medicine was completed at Tulane University.

Professor and Gerald & Flora Jo Mansfield Piltz Endowed Professor in Cancer Research, Department of Biochemistry and Molecular Biology School of Medicine

Wu-Min Deng received his bachelor's degree from Sichuan University in 1991, a master's degree from Shanghai Institute of Cell Biology in 1994, and a PhD from the University of Edinburgh in 1997. After completing his postdoctoral training at the University of Washington, Deng was appointed to the faculty of Florida State University in 2003. The research in his laboratory has led to the development of novel concepts

such as tissue "tumor hot spots" and "compensatory cellular hypertrophy," and publications in high-impact journals. Deng has received continuous external funding, and was awarded the University Developing Scholar Award in 2010, and the Pfeiffer Endowed Professorship for Cancer Research in 2018. Deng was a recipient of the University Honors Mentoring Award in 2013; among the graduate students and postdoctoral fellows trained in his lab, many have moved on to faculty positions. Deng has served as an ad hoc member on multiple NIH study sections, and on the editorial boards of the Journal of Genetics and Genomics and Scientific Reports. In addition, he has served on numerous departmental and university committees, including the University Council on Research and Creativity, the University Senate, the Promotion and Tenure committee, the Chair Selection committee, and the Rhodes Scholar committee.

AUGUSTINE DENTEH, PhD

Assistant Professor, Department of Economics School of Liberal Arts

Augustine Denteh's broad research interests are in applied econometrics and health economics, in which he employs innovative econometric tools to study how public policies affect people's health and well-being. In particular, he works on impact evaluation, measurement error models, the economics of obesity, and food and nutrition programs. Denteh is also interested in techniques for generalizability in health policy using statistical machine learning approaches for causal inference. Before his postdoctoral research fellowship in econometrics at Harvard Medical School, Denteh received his PhD in economics from Georgia State University, an MA in economics from the University of Akron, and a BA in economics and statistics from the University of Ghana. *Expertise: Applied econometrics, health economics, applied microeconomics*

Blair Druhan Bullock earned a PhD in law and economics and a JD from Vanderbilt University. At Vanderbilt, Bullock served as the executive editor for the Vanderbilt Law Review. Before joining Tulane Law School, Blair clerked for Judge Stephen A. Higginson on the United States Court of Appeals for the Fifth Circuit. She then practiced at Bradley Arant Boult Cummings, LLC, where she represented large corporations in civil litigation, including labor and employment, tax, and contract disputes. Her experience includes extensive briefing, both at the trial and appellate levels. Most rewardingly, she was a member of the pro bono trial team that secured the exoneration of a wrongfully convicted man who served over 14 years in a Florida prison. Bullock's interdisciplinary research empirically analyzes the impact of regulation, legislation, judicial interpretations and agency guidance on the filing and outcome of legal actions and on societal outcomes. Her research often focuses on employment discrimination and labor market outcomes. Bullock's scholarship has appeared in the Washington and Lee Law Review and the Oxford Research Encyclopedia of Economics and Finance. Expertise: Employment law

Associate Professor, Department of Microbiology and Immunology and Tulane National Primate Research Center School of Medicine

Tracy Fischer pursued scientific research through nontraditional means, having first studied and worked as a professional musician before receiving a PhD in biology at Temple University. She joins Tulane from the Department of Neuroscience at the Katz School of Medicine at Temple University, where she investigated the impact of chronic inflammation in the brain and periphery and its impact on microglial function and microglia-neuron communication in the context of HIV infection. Fischer's work has advanced the field of HIV and neuroAIDS, demonstrating that perivascular macrophages and microglia are the major reservoirs of productive HIV in the brain in humans and in non-human primate models. Fischer is continuing her work at the Tulane National Primate Research Center, Division of Comparative Pathology, focused on advancing current understanding of the factors that underlie chronic inflammation in the brain in the context of HIV infection and other chronic diseases, as well as in aging and age-related neurodegenerative disorders.

RUBÉN GARCÍA RUBIO, PhD

Rubén García Rubio holds a PhD in architecture from the University of Valladolid (Outstanding PhD Thesis Award), and a PhD in architecture from the University of Roma Tre. He served as a visiting scholar at the American Academy in Rome in 2012. He has taught in several schools of architecture and international institutions in Europe and the Middle East, where he was able to work on several university projects that combined his teaching objectives, research interests and professional work. In addition to his teaching role, García is a practicing architect and is the co-founder of studioVRA. His design and built work has been recognized with several architectural awards and has been published in international architectural weblog CajondeArquitecto.com.

Lee Skinner is the new dean of Newcomb-Tulane College. She received a BA in Comparative Literature from Brown University and then earned a PhD in Spanish from Emory University and began her faculty career in the Department of Spanish and Portuguese at the University of Kansas. Her research focuses on personal and national identity across various dimensions of class, race, ethnicity, and gender in nineteenth-century Spanish American narrative and non-fiction. Her first book, History Lessons: Refiguring the Nineteenth-Century Historical Novel in Spanish America (Juan de la Cuesta, 2006), argues that in nineteenth-century Spanish America, the historical novel allowed writers to explore national, regional, and individual identities as they were simultaneously creating the states that would embody such imaginatively created selves. Her second book, Gender and the Rhetoric of Modernity in Spanish America, 1850–1910 (University of Florida Press, 2016; paperback, 2018), posits

that the linking of gender to social and political agendas, including nationalist thought, was a central preoccupation for Spanish Americans ever since the newly-formed countries confronted the task of defining themselves as true nations after the Wars of Independence.

Skinner has also authored numerous articles in peerreviewed journals in both English and Spanish as well as chapters in edited volumes and has given over 40 invited talks and conference presentations at international conferences. She is currently at work on a cultural history of food and eating in Latin America from 1810 to the present, analyzing not just what people ate and drank but how they thought, wrote, and talked about what they were eating and the ways they ate it. Her book will include the display and sale of food, both domestic and imported, in markets; the preparation and consumption of prepared food in private and public; the etiquette and customs associated with eating; and sociability of food and drink in venues such as coffeehouses, private clubs, and bars.

At the University of Kansas, Skinner served at various times as the departmental Director of Undergraduate Studies, Director of Graduate Admissions to Spanish and Portuguese, and Associate Chair, in addition to directing a summer study abroad program in Mexico multiple times. At Claremont McKenna College, she was the faculty Fulbright Program Advisor for three years before becoming Associate Dean of the Faculty in 2013 with responsibility for the curriculum and academic oversight. She also oversaw the interdisciplinary first-year seminar program and academic advising. Her experience with the Claremont Colleges Consortium, in which five undergraduate colleges work together to provide a seamless academic and residential experience for all students, prepared her well for her position at Newcomb-Tulane College, which spearheads and organizes the key elements of the Tulane undergraduate academic experience. She is passionate about ensuring that students have the best possible educational experience, one that is academically challenging and rewarding.
